7. Deadline of submission of entries is on **June 20, 2018**, 6:00 P.M. GMT.

# TERMS AND CONDITIONS OF THE NESPRESSO VERTICAL SHORTS COMPETITION 2018

## MECHANICS

- Interested participants must register at [www.nespresso.ph/verticalshorts2018](http://www.nespresso.ph/verticalshorts2018), complete all information in the Entry form and submit the following for selection purposes on or before **June 20, 2018 (Wednesday), 6:00 P.M. GMT**:
  - The final work (1) uploaded to [www.nespresso.ph/verticalshorts2018](http://www.nespresso.ph/verticalshorts2018) and (2) submitted to the Film, Broadcast and New Media Division office, 4/F CCP Main Bldg., Roxas Blvd., Pasay City in **DVD format or USB (5copies)**, with violator, labelled with the title, production company address and contact numbers, production date, director's name and running time
  - The duly completed application form;
  - Synopsis in English;
  - A brief résumé/biodata and two (2) recent 2x2 photos of the filmmaker(s).
- Only videos which fall under the General Patronage classification of the MTRCB regulations shall be accepted for the Competition.
- Theme of video - Filipino value "Pagmamalasakit" (Empathy).
- Entries must have been produced between **March 4, 2017 to May 31, 2018**.
- Up to thirty (30) best Vertical short features will be selected and announced as finalists on **July 20, 2018 (Friday)**.
- On or before **July 25, 2018 (Wednesday) 6:00 P.M. GMT** each of the chosen finalists must submit the following to the Film, Broadcast and New Media Division office, 4/F CCP Main Bldg., Roxas Blvd., Pasay City.
  - Soft copy in DVD or USB with English subtitles and violator;
  - HD file (MP4 with bit rate not more than 15mbps) of film with English subtitles
  - DCP and HD file (Apple Pro res HQ) of film with video frame rate of 24fps;
  - Soft copy of the Synopsis and Logline in English;
  - Soft copy of a brief résumé/biodata and profile (bust or medium shot) photo of the filmmaker(s) in jpeg format;
  - Eight (8) captioned horizontal production stills in jpeg format to be used for the souvenir program;
  - Eight (8) copies 8"x10" printed production stills (BTS) for the exhibit (properly labeled at the back);
  - Major credit titles (soft and hardcopy);
  - Original Poster Design in jpeg format;
  - One (1) 20"x30" vertical film poster mounted on sintra board;
  - One (1) iconic item (memorabilia) which figures prominently in the film for the exhibit.
- The finalists will be screened during the 2018 Cinemalaya Philippine Independent Film Festival from August 3-12, 2018 at the CCP Tanghalang Aurelio Tolentino (Little Theater) and Tanghalang Manuel Conde (Dream Theater).
- The top three (3) winners will be announced during the premiere night of the Nespresso Vertical Shorts during 2018 Cinemalaya Philippine Independent Film Festival from August 3-12, 2018 at the CCP.
- Awarding of prizes to the top three (3) winners will be made during the Awards Night of the 2018 Cinemalaya Philippine Independent Film Festival on August 12, 2018 at the CCP Tanghalang Nicanor Abelardo (Main Theater).
- Prizes to be given out are the following:

1st Prize	PhP50,000.00 plus Nespresso Coffee machines and capsules worth Php30,000.00
2nd Prize	PhP30,000.00 plus Nespresso Coffee machines and capsules worth Php20,000.00
3rd Prize	PhP20,000.00 plus Nespresso Coffee machines and capsules worth Php15,000.00

## RULES AND REGULATIONS

- Participants should be Filipino citizens, 18 years old and above.
- Directors, trustees, officers and employees, and their relatives up to the 2nd civil degree of consanguinity and affinity of Cinemalaya, CCP and Novateur Coffee Concepts, Inc. are disqualified from joining the competition.
- Works exceeding 3minutes, inclusive of credit titles, will be disqualified.
- Any genre is acceptable - feature, animation, drama, comedy, etc.
- Due to copyright laws, the video and its elements including but not limited to its dialogue, music, storyline and concept used must be original, licensed or in the public domain.
- Dialogue should be primarily in Filipino or any Philippine language as appropriate, with English subtitles.
- If the proponent includes several individuals, they must assign a single representative to act on their behalf. All official communications shall be addressed to the representative. The Cinemalaya Foundation, Inc., CCP and Novateur Coffee Concepts, Inc. shall not be liable for any controversy regarding the sharing of awards among the members of the group.
- The Festival will ensure safety of the films throughout the period in which the cinematographic materials are in its custody. In case of loss or damage to the materials, the Festival's obligation to the production is limited to compensating only for the cost of replacing the damaged DVD or USB.
- All DVD/USB shipments to the Festival must be prepaid and properly labelled. The Festival cannot accept any collect shipments of any entry.
- The CCP reserves the right to show the Vertical Shorts winning entries and/or the thirty (30) finalists for educational purposes in perpetuity within the CCP venues including CCP-initiated outreach programs, subject to prior information and approval of filmmakers and Novateur Coffee Concepts, Inc.

- The board reserves the right not to give an award should no entry merit it.
- The decision of the Board of Judges is final.

## INTELLECTUAL PROPERTY

- By entering the Competition, the participants declare that the video(s) submitted is their original work, is not based or copied from others or from previous videos, clips, films or other works, including their own, have not been submitted to any other competition, and does not infringe on any third party's existing copyright or any other intellectual property rights. Any claims or complaints that may arise due to similarities, likeness or comparison of the design shall be the sole liability of the Participant, who shall be responsible to prove its originality and his rights to the said video(s).
- The video and its elements including but not limited to its dialogue, music, storyline and concept must not be similar to other existing videos, and other elements owned by third parties.
- Ownership over all intellectual property rights over the submitted videos shall remain with the creators thereof; provided that, by submitting the videos to the Competition, the participants, creators, owners and authors of such videos expressly grants the COMPANY the irrevocable and perpetual right and license, for all matters related to Nespresso, and its brands, and any of its video competitions and promotions, to use, exhibit, reproduce, display, show, screen, air, post, upload, publish, distribute, produce, refine, edit, alter, amend or otherwise rework any of the videos, in whole or any portion thereof, in any manner or by whatever method; provided further that, the COMPANY shall give full credits of the creators and ownership of the said videos whenever the same is shown to the public.
